If you are not able to complete a reference within the deadline, let the nominee know immediately so that they can identify another reference.

Instructions

- Read the Criteria: This award honors individuals who have made a significant, positive difference in their community through community impact and service, innovation, leadership, equity, and systems change. This work must be aligned with the Foundation's mission to advance economic mobility and demonstrate significant contributions to the Kansas City region's well-being, growth, and empowerment.
- 2. **Complete All Sections:** All reference sections on the fillable PDF must be filled for submission. If submitting a letter on letterhead, be sure to include and address each section. Incomplete references may not be considered.
- 3. Provide Specific Examples: When describing the nominee's contributions, focus on key accomplishments related to the award criteria. Use concrete examples, data, or testimonials about their work where possible that illustrate their impact. Additional comments on integrity, leadership, perseverance, or other traits may add weight to their achievements.
- 4. **Deadline:** All reference forms must be submitted by August 15 at 11:59 p.m. CT.
- 5. **Submission:** Upload the completed PDF using the link in your nomination email.
