- 3. **Collaboration**. How do you collaborate with others to achieve collective goals? *You may highlight partnerships, shared leadership, or co-created initiatives.*
- 4. **Innovation.** How do you demonstrate leadership and inspire others to take action or drive change? *Please describe any innovative practices, programs, or ideas you've led or contributed to.*
